Known as the birthplace of whitewater rafting, Ohio's pyle has great rapids with pools below each to celebrate successful passage. We'll start below the falls and shoot our way through the rapids including Cucumber, Walrus, Schoolhouse and even the infamous Dimple Rock! We'll enjoy a riverside lunch along the way provided by Wilderness Voyagers. You will be wet the whole time so be prepared. Bring a change of clothes for the ride home. Your bus departs at 10:30 a.m. sharp! Please arrive early to ensure that you do not miss it. All equipment will be provided including rafts, PFDs, helmets and paddles. Wetsuit rental is available on site for an additional fee. Bathroom facilities will be available before and after the outing.

WHAT TO BRING

Essentials: *Dress for the weather, some exercise, and plan to get wet.*

- Water (you may want a carabineer or similar device to secure your water to the raft)
- Snacks
- Synthetic (nylon, polypro, etc.) shorts or pants and t-shirts or long-sleeve shirts. Do not wear cotton as it stays wet and cold!
- Shoes: Sandals or water shoes that will not fall off your feet. No flip flops!
- Change of clothes for the car, especially extra pants or shorts.

Extras: camera, sunglasses, bathing suit (for hotter weather, if you like), a hat with a brim – to keep the sun out of your eyes (must fit under a helmet), dry bag

Acknowledgment and Assumption of Risk

I acknowledge that by signing this document, I am releasing Venture Outdoors, Inc. (VO) and their respective agents, employees, members, sponsors, promoters, partners, officers, directors and affiliates (collectively "Releasee's") from liability. This release form is a contract with legal consequences. I have been advised to read it carefully before signing.

Venture Outdoors activities covered by this document include: hiking, biking, canoeing, kayaking, rafting, camping, backpacking, snowshoeing, cross country skiing, swimming, fishing, in-line skating, trail maintenance, cleanups, rock climbing, caving, dog activities, outdoor leadership training and any other recreational or educational program offered by Venture Outdoors.

Although VO has taken reasonable steps to provide me with appropriate equipment and skilled staff for the outing for which I have registered, I acknowledge that the activities of this outing have risks, including certain risks which cannot be eliminated without destroying the unique character of the activities. The same elements that contribute to the unique character of these activities can cause loss or damage to my equipment, accidental injury, illness, or in extreme cases, permanent trauma, disability or death. I understand that VO does not want to frighten me or reduce my enthusiasm, but considers it is important for me to know in advance what to expect and to be informed of the activities' inherent risks. The following describes some, but not all, of those risks:

- VO courses and outings may occur in remote places, many miles from medical facilities. Communication and transportation can be difficult and sometimes evacuations and medical care may be significantly delayed.
- Equipment may fail or malfunction, despite reasonable maintenance and use.
- Travel is by vehicle, snowshoe, skis, foot, canoe, kayak and other means, over rugged unpredictable off-trail terrain, including boulder fields, downed timber, rivers, rapids, river crossings, snow and ice, steep slopes, and slippery rocks. Attendant risks include collision, falling, drowning and others usually associated with such travel, including environmental risks.
- Environmental risks and hazards include rapidly moving, deep or cold water; insects, snakes or predators, including large animals; falling and rolling rock; lightning, avalanches, flash floods and unpredictable forces of nature, including weather which may change to extreme conditions without notice. Possible injuries and illnesses include hypothermia, frostbite, sunburn, heatstroke, dehydration, and other mild or serious conditions.
- VO activities are conducted indoors and outdoors, day and night. Physical activities include running, sustained climbing, hiking and repetitive lifting.
- Decisions are made by the instructors, trip leaders and participants usually in a wilderness setting, based on a variety of perception and evaluations which by their nature are imprecise and subject to reasonable errors in judgment. Misjudgments may pertain to, among other things, a student's or participant's capabilities, environment, terrain, water and weather conditions, natural hazards, routes and medical conditions.
- VO participants, including minors, will have unsupervised free time before, during and after their course or outing. Free time activities are not part of the VO program and are at the sole risk of the participants. VO has no responsibility for such activities. VO staff and volunteers may from time to time provide assistance or even accompany participants in these free time activities, but in doing so, they are acting as private individuals, and not for VO.

I am aware that VO activities include risks of my injury or death. I understand the description above of these risks is not complete and that other unknown or unanticipated risks may result in property loss, injury or death. I agree to assume responsibility for the inherent risks identified herein and those inherent risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of and in full knowledge of the inherent risks.

I acknowledge that engaging in this program may require a degree of skill and knowledge different from other activities and that I have responsibilities as a participant. I acknowledge that the staff and volunteers of VO have been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I represent that I am fully capable of participating in the program, without causing harm to others or myself. Therefore I, and my parent(s) or guardian if I am a minor, assume and accept full responsibility for me and for injury, death and loss of personal property and expenses suffered by me and them as a result of those inherent risks and dangers identified herein, those inherent risks and dangers not specifically identified, and as a result of my negligence or otherwise wrongful conduct in participating in these activities. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") **I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE** the Releasee's and the sponsors of this event, the organizer and any promoting organizations, property owners, law enforcement agencies, all public entities, special districts and properties, and their respective agents, officials, and employees through or by which the events will be held, (the foregoing are also collectively deemed to be Releasee's), **FROM ANY** and all rights and **CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE**, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to or return from the event.

I agree it is my sole responsibility to be familiar with the Releasee's rules, and any special regulations for the event. I understand and agree that situations may arise during the event which may be beyond the immediate control of VO. I will follow the instruction and guidance of the trip leader(s). I have no physical or medical condition which to my knowledge, would endanger myself or others if I participate in this event, or would interfere with my ability to participate in this event.

In addition, I hereby grant full permission to the trip leaders, the Venture Outdoors and their respective agents, boards, commissions, and any other involved parties of the foregoing to use photographs, videotapes, motion pictures, or any other record of this event, including my name, likeness and/or voice for any legitimate purpose, including for advertising display, audiovisual presentations or otherwise.

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as consent to any other provision herein or as consent to any subsequent waiver or modification.

Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable. This agreement is entered into voluntarily, after careful consideration and is binding upon the persons signing below, their heirs, executors, administrators, wards, minor children and other family members.

WAIVER AND RELEASE OF LIABILITY

In consideration of Wilderness Voyageurs, Inc. furnishing services and/or equipment to enable me to participate in Whitewater Rafting, Boating Instruction, Mountain Biking, Rock Climbing/Repelling and related wilderness travel, I agree as follows:

I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers and hazards and such exists in my use of miscellaneous River Running, Rock Climbing, and Mountain Biking equipment and my participation in Whitewater Rafting, Boating Instruction, Mountain Biking, Rock Climbing/Repelling and related wilderness travel activities: (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability: (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Wilderness Voyageurs, Inc.; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, including that a guide may misjudge terrain, weather, trail or river route location, and water level, risks of falling out of or drowning while in a raft, canoe or kayak and such other risks, hazards and dangers that are integral to recreational activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of Wilderness Voyageurs, Inc., or by any other person

I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Wilderness Voyageurs, Inc. and its owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of miscellaneous River Running, Rock Climbing, and Biking equipment or my participation in Whitewater Rafting, Boating Instruction, Mountain Biking, Rock Climbing/Repelling, related wilderness travel and any other activities arranged for me by Wilderness Voyageurs, Inc. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of Wilderness Voyageurs, Inc.

I understand that Wilderness Voyageurs, Inc., reserves the right to take photographs or films of any of its river tours, and I hereby agree that Wilderness Voyageurs, Inc., may use such photographs or films containing my picture for promotional and/or commercial purpose.

The Venue of any dispute that may arise out of this agreement or otherwise between the parties to which Wilderness Voyageurs, Inc., or its agents is a party shall be either the City of Uniontown, Pennsylvania Justice Court or the County or State Supreme Court in Fayette County.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE. IT IS MY INTENTION TO EXEMPT AND RELIEVE WILDERNESS VOYAGEURS, INC. FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
